

## ***CCC Corporate Membership***

Clio Country Club's Corporate Membership plans offer you a variety of ways to entertain, reward, and promote your business relationships. A Corporate Membership gives you the flexibility to reward your clients, your employees, and yourself at one of Mid-Michigan's premier private golf clubs. Clio Country Club is located in northern Genesee County, just minutes from Flint, Saginaw, and Bay City. The Corporate Membership plans include greens fees and driving range membership, as well as full use of our lounge, dining and banquet rooms.

### **The following Membership plans are offered for 2018:**

#### ***Ira Bare Membership Option: 1 Primary and 1 Associate Designee - \$5200 annual***

- Unlimited greens fees Monday through Sunday for one primary and one associate designee of the corporation (and their immediate families). League and tournament privileges are also included.
- The primary and associate designees are allowed usage of one privately owned golf cart. Applicable trail fees and storage fees are additional. Otherwise, regular cart rental rates will apply.
- The primary and associate designee may each bring up to three guests per day for play at a reduced rate of 50% off daily greens fees. Guests must be accompanied by the primary or associate designee.
- Driving range membership is included.
- The regular kitchen minimum rate of \$300 per year will apply.

#### ***Selby Membership Option: 1 Primary Designee plus 50 Golf Passes - \$5200 annual***

- Unlimited greens fees Monday through Sunday for one primary designee of the corporation (and his/her immediate family). League and tournament privileges for the primary designee and family are also included.
- The primary designee is allowed usage of one privately owned golf cart. Applicable trail fees and storage fees are additional. Otherwise, regular cart rental rates will apply.
- The primary designee may bring up to three guests per day for play at a reduced rate of 50% off daily greens fees. Guests must be accompanied by the primary designee (or immediate family member).
- 50 Golf Passes to be used by unaccompanied guests, clients, or co-workers - A Golf Pass allows clients and employees to play one 18 hole round with no greens fees charged. Regular cart rental rates will apply.
- Driving range membership is included for the primary designee, as well as guests, clients, or co-workers.

#### ***McCormick Membership Option: 100 Golf Passes - \$5200 annual***

- 100 Golf Passes to be used by unaccompanied guests, clients, or co-workers of a Corporate Member- A Golf Pass allows clients and employees to play one 18 hole round with no greens fees charged.
- Golf cart rental is required and regular cart rental rates will apply.
- The corporation must designate a primary contact person who is responsible for communication with CCC.
- Driving range fees are included for the guests, clients, or co-workers.
- There are no league or tournament privileges for the McCormick membership option.

### **Additional Information:**

- Corporate Memberships are available only to true business organizations. Primary or Associate Designees must be owners, officers, employees, or directors of the corporation.
- Corporations will be required to submit a Corporate Membership application and be approved according to current CCC membership policies.
- The Corporate Membership is an annual membership, and is subject to renewal at the club's discretion. The annual fee must be paid in advance and is non-refundable.
- In order to redeem a Golf Pass, the Corporation must contact CCC with the name(s) of guests, clients, or co-workers. Golf passes may not be transferred or redeemed for cash or credit.
- Voting rights are defined by current CCC By-Laws.
